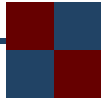

Mission

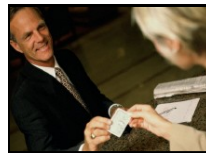
The twenty-first century is in severe need of business leaders to cultivate Biblical business practices. We choose to do not only what is legal, but what is right according to Scripture.
